- Discussion over policy 13.02. Rogers made a motion to strike all compensatory time language. Adkins seconded motion, and the motion passed.

SPIL Amendment Update:

 Salazar provided an update on the technical SPIL amendment. A discussion was held to work with CIL directors, the Board Chair, Treasurer, and others to draft language for the SPIL amendment.

Resource Development:

 Goebel presented on resource development. A discussion was held to move resource development to the next meeting.
