Opening

Texas SILC SPIL Town Hall Meeting

Dr. Lidia Fonseca Ph.D., of VAIL Center for Independent Living, facilitated the Texas SILC SPIL Town Hall meeting in the absence of Pollriesz. Dr. Fonseca gave an overview of the SPIL and public comment was received.

Closed Session

Freeman showed the updated organizational chart. Madam Secretary made a motion to accept the updated chart. McSorley approved the motion and the motion passed.

Vote for Reinstatement

Upon former Public Policy Specialist Mr. Brian White's appeal for reinstatement to SILC staff, Freeman made a motion to deny; Adkins seconded the motion, and the motion passed.

Committee Appointments

Staff Project Presentations

Gernsbacher reported on Peer Assistance Leadership; Covering All of Texas; Inclusive Services for Survivors in Texas; and Good Measure grants.

Vote on having the Policy & Procedure Committee review Addendums 1.0, 1.09, and 1.12

Adkins made a motion, and Rogers seconded the motion to addendum three policies out of the policy. The motion passed.

Financial Report

Whitcomb reported on OVW, Good Measures, TCDD, PAL, and PRC grants. She said auditors would start an independent

audit, and that would take 2-3 weeks. The SILC is transferring the accounting system to an online version, and the SILC adheres to the Texas Prompt Payment Act.

Ex Officio and Liaison Reports

Reports were given by Ex Notargiacomo (TWC); Rowe (HHSC), and Medellin (TxDOT). Rogers had no reports to update.

Freeman requested to put on the agenda for the next meeting that they vote to have a timekeeper for future meetings. Adkins suggested legislative jeopardy.
